- The RBI has allowed offline payment of UPI by using near-field communication (NFC). This will allow users to make UPI payments even when they do not have internet connectivity.
- The Reserve Bank of India (RBI) kept the repo rate unchanged at 6.50% in its August 2023 meeting. The RBI also maintained its stance of withdrawal of accommodation to ensure that inflation progressively aligns with the target of 4%.
