SPOTLIGHT

- India's foreign exchange reserves fell to \$545.65 billion on September 30, 2023, from \$550.08 billion on September 23, 2023. The decline in forex reserves was attributed to the RBI's intervention in the foreign exchange market to support the rupee.
- The Reserve Bank of India (RBI) hiked the repo rate by 50 basis points to 7% in its September 2023 meeting. This was the third consecutive rate hike by the RBI in an effort to tame inflation. The RBI also maintained its stance of withdrawal of accommodation to ensure that inflation progressively aligns with the target of 4%.
